- The Foreign Spouse of an Indian Citizen or Spouse of foreign origin of an OCI cardholder are required to upload a copy of the new passport and also a latest photo ONLINE each time a new passport is issued along with a declaration on subsisting of marriage, copy of the Indian passport of the Indian spouse/passport & OCI card of the OCI cardholder spouse.
- Immediately on uploading of the documents mentioned above, an email will be auto sent by the system to the OCI card holder confirming that the documents have been successfully uploaded. After the completion of verification process, an acknowledgment through email will also be automatically sent to the OCI card holder informing that the updated details have been taken on record.
- There will be no restriction on the OCI cardholder to travel to/from India during the period from date of issue of new passport till the date of final acknowledgment of his/her documents in the online system.
- This service can also be availed for re-issuance/issuance of duplicate OCI documents in the following category of cases:
 - In case of loss/damage of OCI card.
 - In case of change of personal particulars viz. name, father's name, nationality etc.
